ACADEMIC REGULATIONS FOR MASTER OF COMPUTER APPLICATIONS PROGRAMME

(UNDER CHOICE BASED CREDIT SYSTEM EFFECTIVE FROM 2020-21 ADMITTED BATCH)

These Regulations shall be called the "Gayatri Vidya Parishad College of Engineering (Autonomous) Regulations- 2020 for the Award of MCA Degree".

These regulations shall be applicable for students enrolling for MCA Degree programmes at the

Institute from Academic Year 2020-21.

The admission of students shall be as per Govt. of Andhra Pradesh rules. The medium of instruction for course work and examinations at the Institute shall be English.

1. ELIGIBILITY FOR ADMISSION:

Admission to the above programme shall be made subject to the eligibility, qualifications and specialization as per the guidelines prescribed by the AICTE and the State Government from time to time.

2. AWARD OF MCA DEGREE:

A student shall be declared eligible for the award of the MCA degree, if he/she pursues the course of study and completes it successfully for not less than two academic years and not more than four consecutive academic years from the year of admission, otherwise, the student shall forfeit the seat in MCA Programme.

3. STRUCTURE OF THE PROGRAMME:

PE-Professional Elective, SBLE-Skill Based Lab Elective

1 Credit for 1 lecture period per week and 1 credit for 1 tutorial period per week.

1 Credit for 2 laboratory periods per week.

4. REGISTRATION:

A student shall register for courses in each semester according to the choice provided and subjects offered by the concerned department.

5. ATTENDANCE REQUIREMENTS:

- i. A student shall be eligible to appear for end semester examinations if he/she acquires a minimum of 40% in each subject and 75% of attendance in aggregate of all the subjects in a semester.
- ii. Condonation for shortage of attendance in aggregate up to 10% (65% and above and below 75%) in each semester may be granted. A stipulated fee shall be payable to the college towards condonation of shortage of attendance.
- iii. Shortage of Attendance below 65% in aggregate shall in NO case be condoned.
- iv. Students whose shortage of attendance is not condoned in any semester are not eligible to take their end semester examination of that class and their registration shall stand cancelled.
- v. A student will not be promoted to the next semester unless he/she satisfies the attendance requirements of the present semester, as applicable. They shall seek readmission and continue his course of study from that semester when offered next.
- vi. Attendance against each course will be indicated in the marks memo by a letter grade as follows:

Letter grade ' \mathbf{E} ' shall be awarded in case of attendance grade for online courses / any other certificate course offered by external agency.

6. METHOD OF EVALUATION:

The performance of a student in each semester shall be evaluated subject-wise with a maximum of 100 marks for each theory, practical and Project work.

6.1 Theory: The assessment shall be for 40 marks through Continuous Internal evaluation and 60 marks through end semester examination of three hours duration.

Continuous Internal evaluation: One part of the internal evaluation shall be made based on the average of the marks secured in the two internal examinations of 30 marks each conducted one in the middle of the Semester and the other at the end of the semester. Each mid-term examination shall be conducted for a duration of 90 minutes. The remaining 10 marks are awarded through an

average of continuous evaluation of assignments / seminars / any other method, as notified by the teacher at the beginning of the semester.

End-semester examination: An end semester examination shall be conducted for 60 marks. For all the theory courses except electives, the question paper shall be set externally and valued both internally and externally. A chief examiner appointed for each course shall monitor the valuation process. If the difference between the first and second valuations is less than or equal to 9 marks, the better of the two valuations shall be awarded. If the difference between the first and second valuation is more than 9 marks, the chief examiner shall value the script. The marks given by the chief examiner shall be final. For the elective theory courses, the end semester evaluation shall be totally internal with double valuation.

6.2 Laboratory: All the laboratory courses, except 1 credit labs, shall be evaluated for 100 marks, out of which for 40 marks through continuous internal evaluation and for 60 marks through external end semester examination. The 40 internal marks are distributed in two cycles as 20 marks for day-to-day work and 20 marks for internal examination. The internal examination shall be conducted by the teacher concerned and another faculty member once for each cycle of instruction period and average of the two shall be considered for award of marks. 10 out of 12 to 16 experiments/exercises shall be completed in a semester.

6.3 Skill Based Lab Electives / 1 credit Labs: Skill Based Lab Electives shall be conducted from II semester on thrust areas each for a period of 32 hours. For all Skill Based Lab Electives and 1 credit labs, the examination shall be totally internal and conducted for 100 marks at the end of the course.

6.4 Industry Oriented Mini-Project / Internship:

Students shall carryout Industry Oriented Mini-Project / undergo internship during the break between II and III semesters of the Programme. Assessment shall be carried out in III semester through an Internal committee (comprising of HoD, Supervisor and a senior faculty of the department) based on Report, Presentation and Viva-voce for 100 Marks.

6.5 Seminar: There shall be a seminar presentation in IV semester. Assessment shall be carried out for 100 marks through an Internal committee comprising of HoD and two senior faculty of the department.

6.6 Supplementary examinations: Supplementary examinations for the odd semester shall be conducted with the regular examinations of even semester and vice-versa.

6.7 Re-registration for failed courses: A candidate shall be given one chance to re-register for a maximum of two failed courses(s), where in the internal marks secured by a candidate are less than 50%. The re-registration is permitted only after completion of III semester as and when the subject(s) are offered. In the event of re-registering, the internal marks and end semester examination marks obtained in the previous attempt are nullified.

7. EVALUATION OF PROJECT WORK:

- a. A Departmental Project Review Committee (DPRC) shall be constituted with the Head of the Department as the Chairman and two senior faculty as Members to oversee the proceedings of the project work from allotment of topic to submission of the project.
- b. A Project Review Committee (PRC) shall be constituted with a Professor as Chair Person, supervisor and two senior faculty from the CSE / IT departments.
- c. Registration of Project Work: A candidate is permitted to register for the project work in the beginning of the IV Semester, only after satisfying the attendance requirement of all the courses up to III semester. The duration of the project is for one semester.
- d. After satisfying 7c, a candidate has to submit, in consultation with his project supervisor, the title, objective and plan of action of his project work to the DPRC for its approval. Only after obtaining the approval of DPRC the student can initiate the Project work.
- e. If a candidate wishes to change his supervisor or topic of the project, he can do so with the approval of the DPRC. If so, his date of registration for the project work shall start from the date of change of Supervisor or topic as the case may be whichever is earlier.
- f. Candidate shall submit and present the status report during two DPRC reviews after satisfying 7d. The two reviews / evaluation shall carry 20 and 30 marks, respectively. During each review, the DPRC has to approve the status report, for the candidate to proceed with the next stage of work.
- g. A candidate shall be permitted to submit his project work only after the approval of PRC. For the approval by PRC, the candidate shall submit a draft copy of the project work to the Principal through the Head of the Department and shall make an oral presentation before the PRC.
- h. Three copies of the project report, after plagiarism check and certified by the Supervisor, shall be submitted to the College after approval by the PRC.
- i. For the final evaluation of the project work, an external examiner shall be selected by the Principal from a panel of 5 examiners who are experienced in that field proposed by the Head of the Department in consultation with the supervisor.
- j. The final evaluation, i.e., viva-voce examination, for 50 marks, shall be conducted by a board consisting of the supervisor, Head of the Department and the external examiner.

k. A student is deemed to be passed, if he secures at least 25 marks in the final evaluation and 50 marks from both internal and final evaluation put together. If a student fails in project, he/she shall revise and resubmit the project report, in a time frame prescribed by the PRC. If the student fails once again, the project work shall be summarily rejected and the candidate shall change the topic and go through the entire process afresh.

8. PASS CRITERIA:

- a. For all the courses (both theory and laboratory), except 1 credit labs, a student is deemed to be passed if he secures at least 24 marks (40%) in the end semester examination and 50 marks (50%) from both internal and end semester examination put together.
- b. For SBLEs, other 1 credit lab, and Industry oriented Mini-Project / Internship and Seminar having examination / evaluation at the end of the course, a student is deemed to be passed if he secures at least 50%.
- c. For project work, the student shall PASS as per the criteria 7.k.

9. GRADING:

After each subject is evaluated for 100 marks, the marks obtained in each subject will be converted to a corresponding letter grade as given below, depending on the range in which the marks obtained by the student fall.

Grade Point: It is a numerical weight allotted to each letter grade on a 10-point scale. *Letter Grade:* It is an index of the performance of students in a said course. Grades are denoted by letters A+, A, B, C, D, E and F.

Calculation of Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA):

i. The Semester Grade Point Average (SGPA) is the ratio of sum of the product of the number of credits with the grade points scored by a student in all the courses taken by a student and the sum of the number of credits of all the courses undergone by a student, i.e.

 $SGPA = \Sigma (Ci \times Gi) / \Sigma Ci$

where, Ci is the number of credits of the ith subject and Gi is the grade point scored by the student in the ith course

- ii. The Cumulative Grade Point Average (CGPA) will be computed in the same manner taking into account all the courses undergone by a student over all the semesters of a programme, i.e. CGPA = Σ (Ci × Si)/ Σ Ci where 'Si' is the SGPA of the ith semester and Ci is the total number of credits in that semester
- iii. Both SGPA and CGPA shall be rounded off to 2 decimal points and reported in the transcripts.
- iv. While computing the SGPA/CGPA, the subjects in which the student is awarded Zero grade points will also be included.

10. AWARD OF CLASS:

After a student has satisfied the requirements prescribed for the completion of the programme and is eligible for the award of MCA degree, he/she shall be placed in one of the following:

CGPA to Percentage of Marks Conversion:

At the end of the Programme, Equivalent percentage of marks = (CGPA-0.75)*10

Transcript for each semester shall be issued containing letter grades and grade points along with attendance grade, for each of the courses registered, SGPA of that semester and CGPA up to that semester. Marks will not be displayed on the transcript. A consolidated transcript indicating the performance in all semesters shall also be issued.

11. MINIMUM ACADEMIC REQUIREMENTS FOR AWARD OF DEGREE:

A student shall secure a PASS in all courses & earn 80 credits to be eligible for the award of the MCA degree.

General:

- i. Where the words "he", "him", "his", occur, they imply "she", "her", "hers", also.
- ii. The academic regulation should be read as a whole for the purpose of any interpretation.
- iii. In the case of any doubt or ambiguity in the interpretation of the above rules, the decision of the Chairman, Academic Council is final.
- iv. The college may change or amend the academic regulations or syllabi from time to time and the changes or amendments made shall be applicable to all the students with effect from the dates notified by the college.

TRANSITORY REGULATIONS FOR RE-ADMITTED STUDENTS

- 1. The re-admitted students shall continue his/her course of study as per the course structure, syllabus and evaluation shall be in accordance with the regulations under which the student was first admitted.
- 2. For the subject(s) failed in earlier semesters (before re-admission), the student has to acquire credits from the supplementary examinations as and when conducted.
- 3. The decision of the Principal is final on any other clarification in this regard.
- 4. In case of transferred students from other University / College, an equivalent course structure shall be prepared by the BoS of respective department considering the suitable credits already acquired at the previous institution.



- 1. Ragging is prohibited as per Act 26 of A.P. Legislative Assembly, 1997.
- 2. Ragging entails heavy fines and/or imprisonment.
- 3. Ragging invokes suspension and dismissal from the College.
- 4. Outsiders are prohibited from entering the College and Hostel without permission.
- 5. Girl students must be in their hostel rooms by 7.00 p.m.
- 6. All the students must carry their Identity Cards and show them when demanded
- 7. The Principal and the Wardens may visit the Hostels and inspect the rooms any time.
